Patent and Intellectual Property Protection & Fines

Offenders who infringe upon our patent rights by producing or selling counterfeit versions of the BlackMOA[™] will face claims for damages, with penalties ranging from USD 5 million to USD 20 million, depending on the severity of the infringement.

Distribution and Reseller Policies

Myst Enterprise Ltd enforces strict policies regarding the distribution and resale of BlackMOA™ products to protect our brand's integrity, value, and reputation.

1. Authorized Reselling and Pricing:

All *authorised distributors* and resellers must adhere to the pricing guidelines set by mutual consultations & agreement with Myst Enterprise Ltd. Selling or advertising BlackMOA[™] products at a price unexpected than authorized/consulted price will result in legal consequences.

2. Distribution Integrity and Legal Enforcement Policy
